BRAD STAFFORD MADE THE MOTION TO ADOPT THE FY2019 BUDGET FOR TERRELL COUNTY AND HAVE THE CHAIRMAN SIGN THE SAME. ERNEST JOHNSON GAVE THE SECOND. THOSE IN FAVOR OF THE MOTION WERE BRAD STAFFORD, ERNEST JOHNSON, AND LUCIUS HOLLOWAY. THE MOTION CARRIED.

SHE STATED THE COMMISSIONERS WILL HAVE TO ADVERTISE THE FIVE YEAR HISTORY FOR TWO WEEKS AND ALSO ADVERTISE A PUBLIC HEARING AND THEN DO THE ORDINANCE FOR THE BUDGET. SHE REPORTED THE AUDITOR BILL WILLIAMS IS WAITING ON THE TAX COMMISSIONER FOR THE CONSOLIDATION OF THE DIGEST IN ORDER FOR HIM TO PREPARE THE FIVE YEAR HISTORY. ** CORRECTIONS TO PREVIOUS STATEMENT FROM CHARLENE FARMER: SHE MEANT TO STATE THE COMMISSIONERS WILL HAVE TO ADVERTISE THE FIVE YEAR HISTORY FOR ONE WEEK OR SEVEN DAYS AND ADVERTISE A SPECIAL MEETING TO SET THE MILLAGE RATE AND THEN DRAFT AND APPROVE A RESOLUTION TO LEVY THE TAXES.
